International Awarding Fee Structure - 2010 to 2012



CUC is Non Governmental; Non Profit Private Corporation incorporated and licensed in UK as a Private Independent Professional Knowledge University facilitating their own Work Oriented Professional Degree Qualification under the notion of Learning and Experienced. This award of CUC is inconsideration to the Incorporation Constitution of the ExCUCtive Board of Governors

In order to receive awarding documentation, the applicant initially must forward the CUC completed Application Forms, documentation and Specified Non Refundable Registration Fee appropriate to the award that candidate seeks.

Applicants must provide with the detailed CV either by email or Fax or post to the International Co-Ordination Centre for advice/ initial consideration of suitability of award sought.

Candidates are eligible to apply for Scholarship. Eligibility is determined by the Providers or CCT Bursary Committee. Fees are subject to changes with one week notice. On confirmation of the application, all applicants must remit the appropriate fee to the University Bursary by forwarding the payments to the International Co-Ordination Centre. All payments must be made payable to CUC. The fee structure which is agreed at the time of registration will be honoured on completion. It is advised to all candidates that all payment must be made directly to the university bursary either by Bank Draft or TT in the currency of USA Dollars or UK Sterling.

The Choosing of the Scheme of Award is depending on the candidate's personal choice of requirement. Once the selection of scheme is confirmed the appropriate fee has to be paid for the process of the application. It is also notified to the prospective candidates that once the decision is made applicant has to send the Non Refundable Registration Fee to the university to carry out the initial process of the application. If any reason the Non Refundable Registration is

not remitted, the university is not responsible to forward the conditional offer letter. This stipulation will be adhering at all time by the university's administration office. No debate will be entertained by the university officials.

Special Foot Note:-

It is hereby notified by ExCUCtive Board of Governors of CUC that all prospective candidates before enrolling to gain a reputable Professional Knowledge Qualification from CUC, must have read and understood the Philosophy and Fee Chart of CUC. It is the total responsibility of the candidate to ensure that the CUC award is right for them and they have selected on their freewill after their own research. CUC will not be held any responsible of the candidate's choice. Once the application is made, candidate is committed irrevocably to pay the Non Refundable Administration fee, if they change their decision for whatever the reason can be, no refund will be paid.
